## Christmas Fayre


This evening the Christmas Fayre is from 3.30pm to 5pm. Come along for some fun to join in the activities and games. Please see poster attached.

## School Hours Changing from January 2024

Another reminder, our school hours will be changing from January 2024 due to new government expectations that schools are open to children for 32.5 hours a week or 6.5 hours a day.

We will open the gates for children to come in at 8:40am and the register will be taken at 8:50am. This means all children will need to be in school and in class by 8:50am.

Children will be marked with an L code until 9am and after 9am children will get a U Code. If a child has eight U codes in a ten week period you are likely to receive a penalty notice.

Reception, Year I and Year 2 will finish at 3:20pm.

Year 3, Year 4, Year 5 and Year 6 will finish at 3:25pm, so we can get everyone safely to their adults at the end of the day.

Breakfast club will continue to start at 8am and will remain free for children.

Nursery hours will stay the same as their entitlements are different.

# Ordering Lunches

Please remember to order your child/ren's lunches online each week or a term in advance, so they are not disappointed.

#### <u>Lateness</u>

Please can you make sure your children arrive coming to school. We are regularly having children arriving after 9am and from January 2021 hours are changing and children will need to be in even earlier. We understand there may be a one-off issue, and if so please phone and let us know if your child is going to be late.





#### Dear Parents/Carers

As we go into the festive period, we would like to remind you about the law regarding electric scooters. It has become apparent that some young people have already acquired or are in the process of acquiring electric scooters for their own use.

The only electric scooters that can only be used on public roads are those that are hired as part of the government-backed trials. We would also remind you that to use these trial scooters you must be at least 18 years old and hold a full or provisional driving licence. Private e-scooters can only be used on private land (with the landowner's permission) and not on public roads, cycle lanes or pavements.

Electric scooters are classed as powered transporters and fall within the legal definition of a motor vehicle under the Road Traffic Act 1998. This means that the same rules that apply to motor vehicles, apply to e-scooters. This includes, but isn't limited to:

- Driving with a licence
- Driving/riding with insurance
- Driving/riding other than on a road

It is not currently possible to get appropriate insurance for privately owned e-scooters meaning that it is illegal to use them on roads or public spaces. If a child or adult is found riding a private e-scooter on a public road or fand the scooter may be seized, and the person, including children could be liable for prosecution for driving without insurance. If the child or adult doesn't hold a provisional or full licence and is stopped riding an e-scooter, they could be prosecuted for driving other than in accordance than with a licence, as well as having no insurance. Penalty points can still be issued where a licence isn't held. These points would take effect when the child or person applies for a driving license.

Our aim is to keep children safe and out of the criminal justice system. We want to keep you informed so that we can work together to do this.
